MINUTES

Meeting called to order 2:02pm

President Ed Lyons stepped down from his position December 1st for personal reasons. Doug McDermod, Treasurer, stepped in to fill the position and Manager Phil Wharton became the Treasurer.

Doug made introductions and gave an overview of the past year. There were some staffing changes, and LLC membership was at 79 units. *Direct deposit* was introduced, *the Website* was revamped, and *the Valley* offered some complimentary activities which was a positive for the LLC's rental program.

Stacey Metivier, General Manager, introduced her team: Christine, Front Desk Supervisor; Ashlee, Housekeeping Supervisor; Marc, Maintenance Supervisor. She noted this was the first time she has had a full month of having a solid team.

Phil Wharton, Treasurer, reported a profit of \$38,258 this year which is up from last year's profit of \$5,299. The Revenue goal was not met, but because of expenses being managed a profit was realized. The revenue mix totaling nearly \$1.4 million included 4.5% Groupon and 30.1% Hockey. Owner distributions exceeded half a million dollars for the fifth consecutive year. Each quarter's revenue was compared to the previous year's quarters, and variables that impact revenue results were noted.

Waterville Valley Sales brings in conference events, weddings and other groups and reserves rooms throughout the Valley. BBL website, Facebook, other social media, and direct email blasts and OTA's brings in other business.
